9/7/11 Spud well at 4:00 pm on 9/7/2011. Drill 12.25" hole to 263'. Run 6 jts. 9.625" 32.3# H-40 ST&C casing, set at 255'. Cement with 150 sks. of Class G cement, 2% CaCl2, 1/8#/sk poly-e-flake (175.5 cf). Bumped plug with 500#, shut in well with 150#, cement in place at 1:00 pm on 9/8/11. Circulated 12 bbls of cement to surface. Cement job witnessed by Jicarilla BLM representative. WOC. Pressure test casing to 700# for 30 minutes - ok. Test BOP 250# low - 15 minutes and to 2000# high - 15 minutes - ok.
