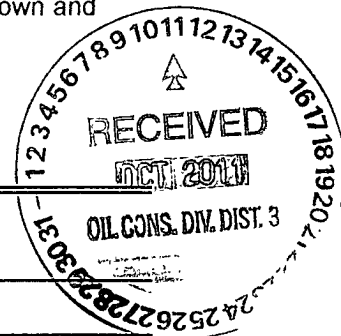

Elm Ridge Exploration Co LLC has performed the Gallup completion in the above referenced well. We set a composite bridge plug at 6448' and selectively perforate the Gallup from 5391' 5680'. The perforations were broken down and the formation fracture stimulated as follows: Acid; Pumped 1200 gals of 7 1/2% MCA acid w/ clay stabilizer, HA I-404, FE 1A, Losurf 300D, Musol w/ double inhibited & iron sequence. Frac; Pumped 1430 MSCF/N2, 31933 gals of 17 CP Delta 140 w/ BBC frac fluid, 105739 gals of 17 CP Delta 140 w/ BBC frac fluid, 1444 sacks of 20/40 CRC with max BH concentrate. Ran 166 joints of 2 3/8" 4.7# J55 tubing, EOT @ 5713'. Rigged down and moved off of location.
