In our discussions, agreement was reached that the state's plugging reclamation fund should be used to enter and plug these wells properly since the operator has been absent since the 1970's and there is no bonding in place. If you concur with this proposal, please provide a written concurrence so that the process of plugging the wells can begin. Copies of the plugging plans have been enclosed as requested.

We appreciate all the assistance NMOCD has provided in dealing with unplugged wells and look forward to more cooperative efforts in dealing with this issue.
