- Move in and Rig Up well service unit
- Kill well as necessary with viscous fluid
- Trip out of hole and lay down rods, pump and production tubing
- Remove wellhead
- Secure well with 4 1/2" X 2" swage and ball valve
- Move rig out
- Rig up cementing company to well
- o Mix 30sx lead cement with 2%CaCl2, 1/4#/sx cellophane, 3#/sx gilsonite to 15.6 ppg followed by 70sx cement with 2%CaCl2 at 4bpm
- o Do not displace cement
- o Wash up equipment to water tank with 25# sugar added
- Wait overnight
- If cement is not at surface, tag and top with neat cement as necessary
- Dig out, cut off, install marker, remediate location as indicated in conditions of approval

Other sundries of intent to plug and abandon will be filed on additional wells Please approve the above plan for execution in the next 180 days to allow time for preparation and scheduling of additional wells
