Spud 12-1/4" hole on 10/1/2011. Drill to 355'. Set 9-5/8" 36 lb/ft J-55 casing at 352'. Cement with 248 cu ft (200 sx) Type III cement + 2% BWOC CaCl₂ + 1/4# celloflake/sx + 59% H₂O. Circulate 10 bbls cement to surface. Pressure tested pipe & blind rams high 3000 psi for 30 mins, held, low 250 psi for 5 mins, held. Tested choke manifold, choke line, kill line, Kelly valve, TIW valve high 3000 psi for 30 mins, held, low 250 psi for 5 mins, held. Pressure test casing at 800 psi for 30 min, held.
