The APD for the subject well was approved by BLM 3/15/07. The proposed location was built, however drilling of the well was first postponed due to pipeline ROW negotiations between the Jicarilla Apache Nation and Williams Field Service and then due to the downturn in the economy. JAECO was granted an APD extension by BLM which expired 3/15/2011. JAECO plans to drill this well by the end of 2011, pending permit and rig availability. JAECO respectfully requests that the APD be extended to March 31, 2012.
