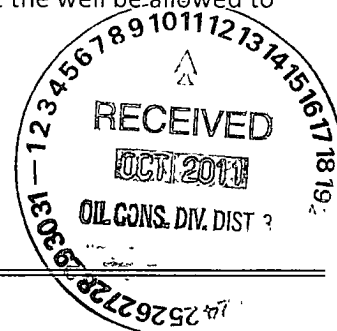

Caerus Southern Rockies LLC recently acquired the Tsah Tah well in an acquisition from Rosetta. Caerus has been reviewing all the wells in the field and has done several "Coal Stims" on existing wells and has just recompleted a State well to the Fruitland Coal and fraced this well on 9/22/11. Because Caerus is still evaluating all the wellbores in the field and performing a detailed geologic analysis, Caerus respectfully asks for a 9 month extension to the recently received notice to restore production or plug the well. Caerus therefore asks that the well be allowed to remain shut in for a period of 9 months to properly evaluate its productivity.
