Cement with 210 sks. 65/35 Class G/Poz with 6% gel, 2% CaCl2, 5#/sk coal seal and 1/8#/sk poly-e-flake. (414 cf), tail with 65 sks. Class G with 5#/sk coal seal, 1/4#/sk poly-e-flake (79 cf). Plug down at 11:45 am on 10/5/11. Pressure up to 1500#-held ok. Check float-did not hold. Pressure up on casing to 500# and shut in - witnessed by V. Jameson with BLM FFO. Circulated 20 bbls cement to surface.

Will pressure test casing upon completion.
