Pumped 2102 sks of 20/40 CRC (210000#) w/ max BHC of 4.6 lb/gal. 10-22-11: Run in hole w/ 153 jnts of 2 3/8" 4.7# J55 tbg. Landed tbg @ 4942'. 10-23-11: Shut well in at 7am. Begin installing production equipment. 10-24-11: Rig down and move off location. ✓
