08/06/10 Drill 8.75" hole to 5200'. Run 116 jts. 7" 23# J-55 LT&C casing, set @ 5195'. RU Halliburton. Cement first stage with 70 sks PRB II, 5#/sk gilsonite, 1/4#/sk flocele tailed by 50 sks PRB II, 5#/sk gilsonite, 1/4#/sk flocele. Plug down @ 12:00 pm on 08/07/10. Circulate 3 bbls cement to surface. Circulate between stages. Cement second stage with 380 sks PRB II, 5#/sk gilsonite, 1/4#/sk flocele (968 cu.ft.). Plug down @ 5:15 pm on 08/07/10. Circulate 5 bbl cement to surface. WOC. RD Halliburton. ND BOP. Rig moved off after setting 7" casing. We will re-enter @ a later date.
