

10/14/11 Completion rig moved onto location. ND WH. NU BOP. TOH with 2.875" 4.7# J-55 EUE tubing.

10/15/11 Clean out and flowback well.

10/23/11 Acidize with 36 bbls of 15% citric acid. Swab back acid.

10/25/11 Run 109 jts. 2.375" 4.7 J-55 production tubing, set at 3474'.

Perforations are at 3753'-7770' - pre perforated 4.50" production liner. ✓
