10/15/11 Perforate the 4.50" 11.6# J-55 liner with 6 SPF at a 60 degree phasing at 4230'-4250', 4354'-4374', 4480'-4500' (6 spf, 360 holes). Swab well. Acidize with 1500 gallons of 15% HCL. Swab, clean out and flowback.
