On Septemeber 8, 2010, the BLM approved the Temporary Abandonment on this well. We set a bridge plug within 50' of the top perf (top perf is at 3,910') and then did a Mechanical Integrity Test.

We would like to request that this well once again be approved by the BLM as A Temporarily Abandoned well, so that further evaluation may be conducted pertaining to possible recompleat in this well.
