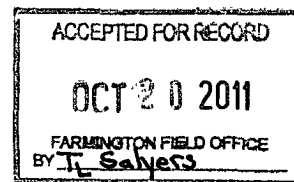

Cement with 170 sks. of 65/35 Class G/Poz with 6% gel, 2% CaCl2, 5#/sk coal seal, 1/8#/sk of poly-e-flake (334.9 cf) and tail with 150 sks. of Type G, 2.5#/sk of coal seal, 1/4#/sk poly-e-flake (183 cf). Plug down at 12:15 pm on 10/16/11. Circulated 10 bbls of cement to surface.

Will pressure test casing upon completion.
