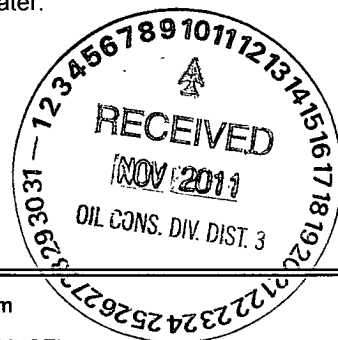

Tail w/70 sx Type III cement + 1% BWOC CaCl₂ + 1/4# celloflake/sx + 0.2% BWOC FL-52A + 59% fresh water. Displaced w/23 bbls water. Pumped 21 bbls cement to surface. Wayne Smith Drilling Released 10/28/11. Pressure test casing to 3000 psi for 30 mins, held ok.
