Gas Analysis indicates PC gas. Requested permission to Perf @ 2950' & circ. cmt to surface. BLM approved. OCD requested CBL be performed. 11/28/11 Notified OCD (Brandon Powell) of CIBP set @ 3124' and CBL was performed in 1978. OCD requested noise log. 11/28/11 Noise log performed. 11/29/11 Notified OCD (Brandon Powell) of noise log & CBL results. Channel issue from PC. CBL shows cmt throughout well & it fell back. Cmt will not be able to circ to surface. Requested to perf @ 2425' & block sqz. Monitor BH for period. OCD requested sqz from 3170' - 3150'. Notified BLM (Jim Lovato) & OCD (Brandon Powell) of request to P&A well because channeling indicated where the cmt fell back and csg tested with low BH pressure and do not feel sqz will be successful. Verbal approval received. Approval received from BLM to have rig in closure area until 12/6. Current rig cannot P&A well. P&A rig will move on location 12/2. 11/30/11 POOH w/ tbg. ND BOPE. NU WH. RD RR @ 17:00hrs on 11/30/11. 12/1/11 Notified BLM (Jim Lovato) & OCD (Brandon Powell) of PA procedure. Request to vent gas from BH over seasonal closure and monitor BH since csg tested to be evaluated in the spring and not P&A well at present time. Verbal approval received with stipulations.
