Tail w/70 sx Type III cement w/1% BWOC CaCl₂ + 1/4# celloflake/sx + 0.2% BWOC FL-52A + 59% fresh water. Displaced w/20 bbls water. Circulate 12 bbls cement to surface. Wayne Smith Drilling released on 12/1/11. Pressure test will be reported on completion sundry.
