11/27/11 - 11/28/11: NU BOP. Pressure test casing to 1500#/30 minutes. OK. Test choke manifold 250 psi low/5 mins, 2000/10 min. OK. Test BOP 250 psi/5 min; 2000 psi/ high10 min. OK. Test pipe rams 250 psi low/5 mins, 2000 psi high/10 mins. Test upper kelly valve 250 low/5 mins, 2000 high/10 mins.
