Circ 30 bbls cmt to surf. 3rd stage: mix & pump 385 sx C/G Premium Light cmt, 12.3 ppg & 1.95 yield, tail w/100 sx 50/50 poz Premium, 15.8 ppg & 1.15 yield. Circ 45 bbls good cmt to surf.
