In accordance with Order #DHC-4507, it is intended to downhole commingle the Blanco MV (72319) and Gavilan Pictured Cliffs (77360). The existing MV perforations are 5614'-6132' and the estimated PC perforations are 3824-3850'. A CBL will be run from around 5,000' to surface to determine TOC. Once TOC is determined, squeeze holes may be shot and may attempt to circulate cement to surface. Selectively perforate and fracture zone. Clean out to PBTD. Run tubing & put well on production. Recommended allocation will be by the Subtraction method following 60 days of stabilized production. Commingling will not reduce the total remaining production's value. The interst owners are identical for each zone. Rates reported to MNOCD - Aztec for final determination.
