On 1-20-12 146 joints of 5 1/2" 15.5# J55 casing was set at 5941'. **First Stage:** LEAD with 240 sks Halliburton Light Premium cement. TAILED with 200 sks POZ Premium 50/50 cement and circulated 40 bbls to the surface. **Second Stage:** LEAD with 680 sks Premium Light cement. TAILED with 50 sks Premium Class G cement. Circulated 40 bbls to the surface. Used a total of 1170 sks of cement. DV Tool set at 3726'. Pressure test to 2000 PSI for 30 minutes, test was good. Moved rig off location at 12:00 on 1-20-12. A
