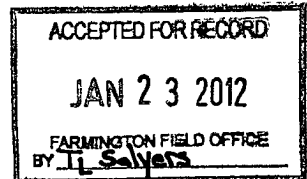

JAECO spudded the subject well @ 9:30 am, 1/10/2012. Mo-Te Surface Rig 212 air drilled a 12 1/4" hole to 321' GL. 1/11/2012 Mo-Te ran 9 5/8" 36# J-55 STC: Sawtooth Collar, 2 jts csg, insert float, 13 jts csg for a total of 316' casing, set at 315' GL with insert float at 274' GL. Mo-Te cemented casing using: 10 bbls pre flush + 6 cu yds, 162 cf, Type 1-2 14.7ppg redi-mix cement followed by wood wiper plug, 21 bbls fresh water. Bumped plug to 250 psi @ 1:00 pm, 1/11/2012, checked float - held. Circ 6 bbls cement to surface. 1/12/2012: set cellar, weld on 9 5/8" csg head, tst weld to 1200 psi, Well-Tech pressure tested csg-hd/9 5/8" csg to 700 psi for 30 minutes - held. Rig down & move out Mo-Te. Wait on Drilling Rig. Cement job witnessed by Bryce Hamond, JAOGA.
