TAILED with 100 sks of 50/50 POZ Premium cement and circulated 30 bbls good cement to surface. **Second Stage:** LEAD with 505 sks Halliburton Light Premium cement. TAILED with 50sks Class G cement and circulated 40 bbls good cement to surface. Used a total of 863 sks of cement. DV tool set at 3482'. Pressure tested to 2000 PSI for 30 plus minutes, test was good. Moved rig off location at 6:00 am 1-30-12. A
