Recovered 20 bbl cmt to surf. 2nd stage: mix & pump 380 sx Premium Light cmt (12.3 ppg, 1.96 yield), tail w/ 100 sx 50/50 Poz Premium cmt (15.8 ppg, 1.15 yield). Recovered 38 bbl cmt to surf. 3rd stage: mix & pump 400 sx Premium Light cmt (12.3 ppg, 1.94 yield), tail w/ 100 sx 50/50 Poz Premium cmt (15.8 ppg, 1.15 yield). Recovered 41 bbl cmt to surf.
