D.J. Simmons, Inc. plans to Plug and Abandon the subject well with the following procedure:

- Move in and Rig Up well service unit
- Kill well as necessary with viscous fluid
- Trip out of hole and lay down rods, pump and production tubing
- Remove wellhead
- Secure well with 4 1/2" X 2" swage and ball valve
- Move rig out
- Rig up cementing company to well
  - o Mix 30sx lead cement with 2%CaCl2, 1/4#/sx cellophane, 3#/sx gilsonite to 15.6 ppg followed by 50sx cement with 2%CaCl2 at 4bpm; Displace cement with 5 1/2 barrels water to leave cement at 350' which is 150' above annular top of cement at 500'; Wait on cement
- Rig up wireline
  - o Tag cement; Perforate 4 squeeze holes at 300'
- Rig up cementing company to well
  - o Mix and pump 60sx cement with 2%CaCl2 down casing and circulating through annulus to surface; Do not displace cement; Wash up equipment to water tank with 25# sugar added
- Wait overnight; If cement is not at surface, tag and top with neat cement as necessary
- Dig out, cut off, install marker, remediate location as indicated in conditions of approval
