Circulate 5 bbls cement to surface. WOC. ND BOPE. RD RR @ 17:00 hrs on 3/5/12.

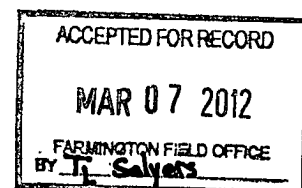
