Elm Ridge Exploration replaced the pump and several joints of bad tubing (40 jts 2 3/8" J55 4 7# EUE) (End of tubing is at 1341') on 12/7/2011. The well has been returned to pumping. Please note that due to the extended shut in time for this coal well, a considerable amount of water will need to be produced before gas prodution is resumed.
