08/1/06 RU Blue Jet and ran Cased Hole Neutron Log from 1964' to 1400'.

3/19/12 Set a 5,000# frac valve and pressure tested the valve and casing to 3,500 psi for 30 min – held OK. Blue Jet perforated the Aztec PC at 1898' – 1910' at 3 spf (0.36" holes). Total 36 holes. Fraced the PC with 500 gal of 15% HCl, 52,000# of 20/40 sand in 671 bbls of x-linked fluid.

3/20/12 Set a CBP at 1890'. Perf the FTC at 1858' – 1882' at 3 spf. Total of 72 (0.5") holes. Fraced the Basin Fruitland Coal with 458 bbls of 15#/1000 gal. x-linked, 576,601 SCF of nitrogen, & 81,000# of 20/40 Sand.

3/26/12 RU JC Well Service. Cleaned out the well to PBTD with air/mist. Ran 60 jts of 2-3/8", 4.7#, J-55 EUE tubing and landed it at 1932' KB. Ran a 2" X 1-1/2" X 10' RWAC pump on 3/4" rods and seated it in the seating nipple at 1900' KB. Rigged down JC Well Service and turned the well over to production. 1<sup>st</sup> Deliver well 3/29/12.
