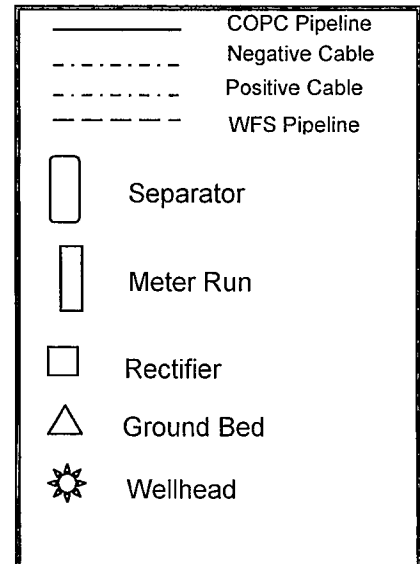
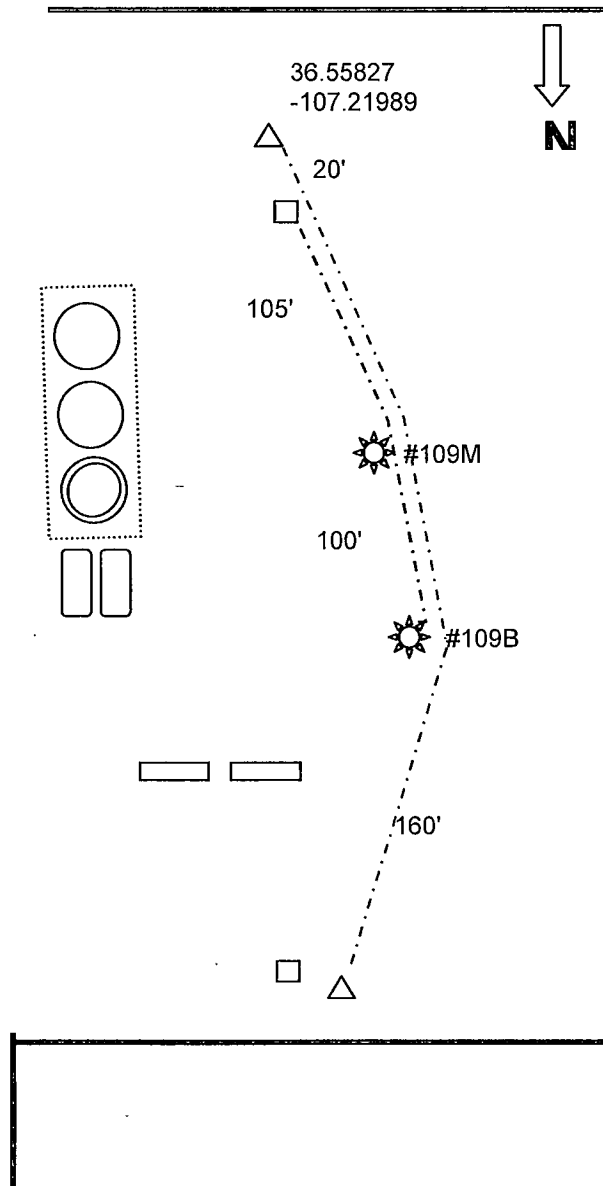

## San Juan 27-4 #109M

Section 23, T27N, R04W, N.M.P.M., Rio Arriba County, NM



Drill ground bed approximately 125' southeast of #109M wellhead at staked location. Remove existing solar unit and replace with a twin-well solar unit at staked location near new ground bed. Install cables to both ground beds, #109M and 109B wellheads at lengths below.
