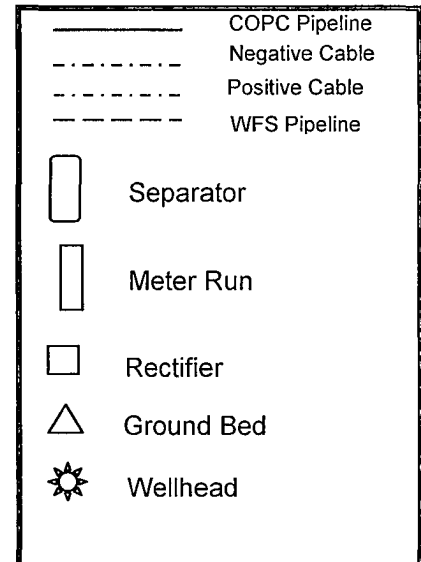
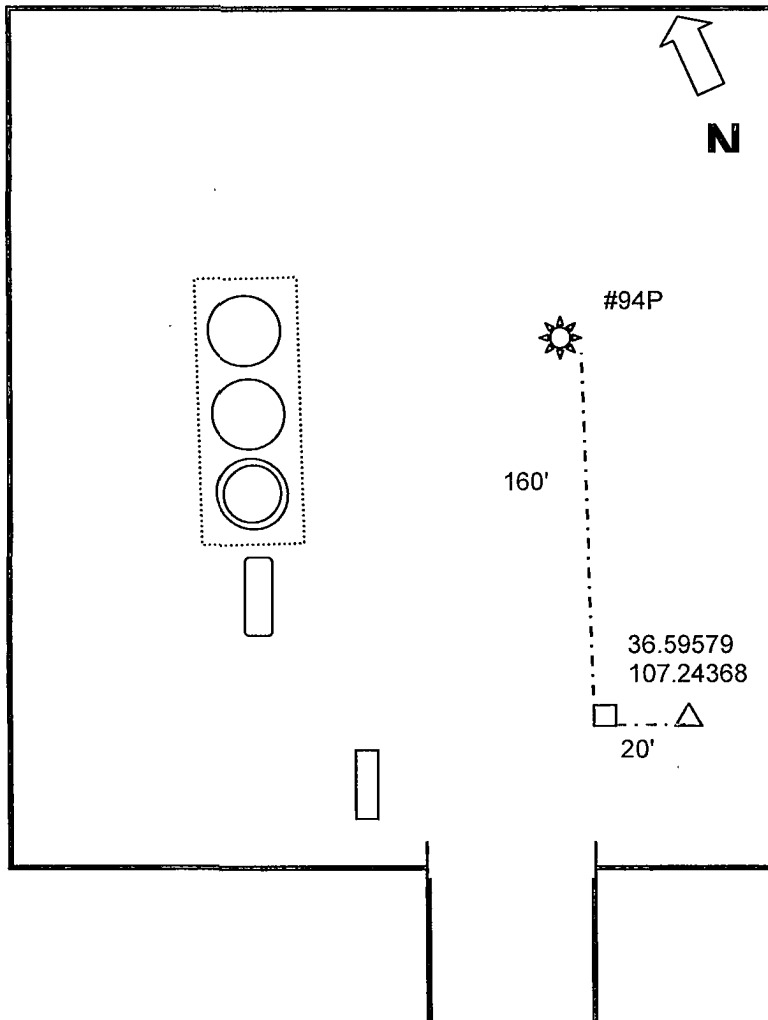

Drill ground bed approximately 160' south of #94P wellhead at staked location. Install single-well solar unit and install cables to new ground bed and #94P wellhead at lengths below.
