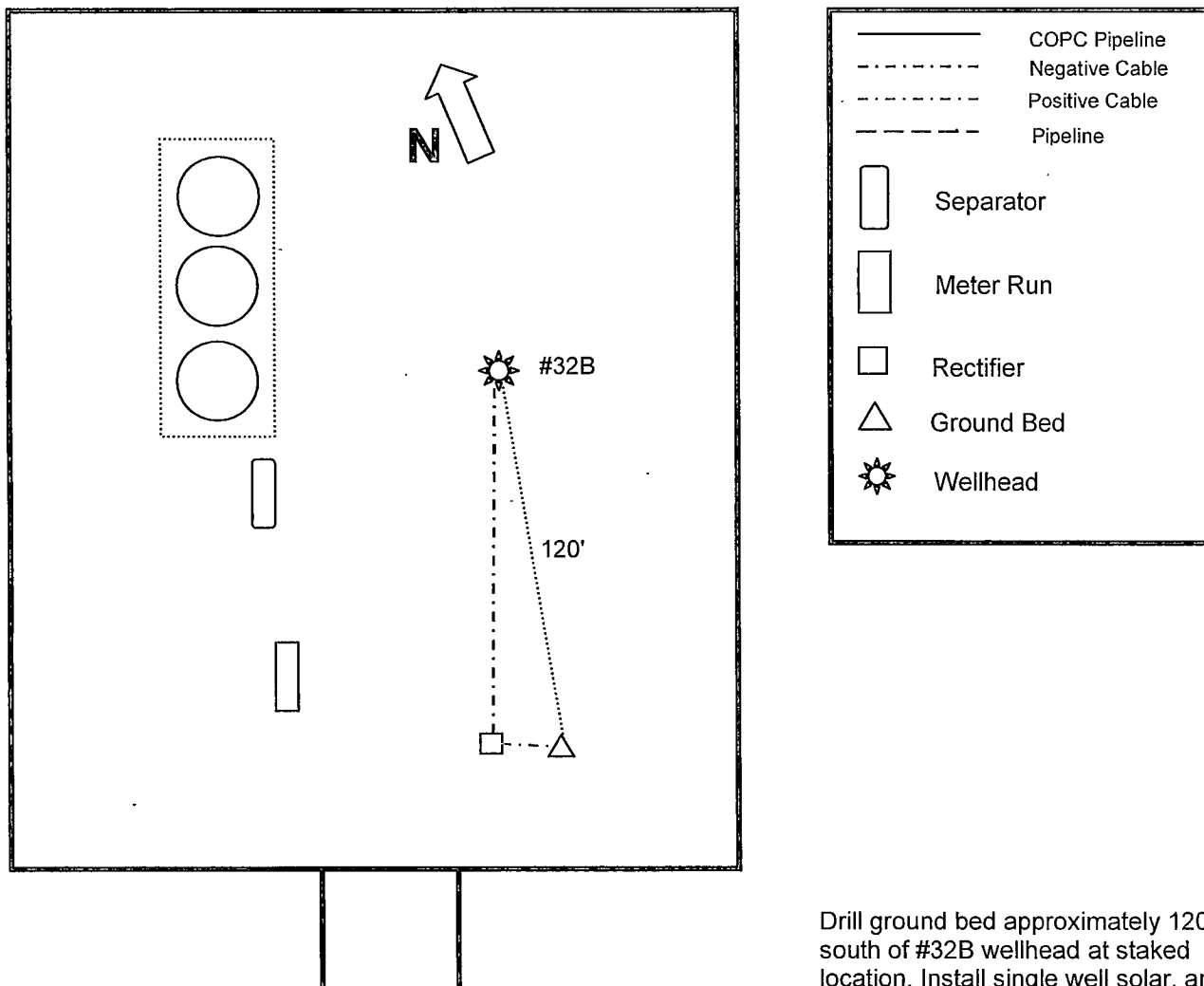

Drill ground bed approximately 120' south of #32B wellhead at staked location. Install single well solar, and install cables to new ground bed, and #32B wellhead at lengths below.
