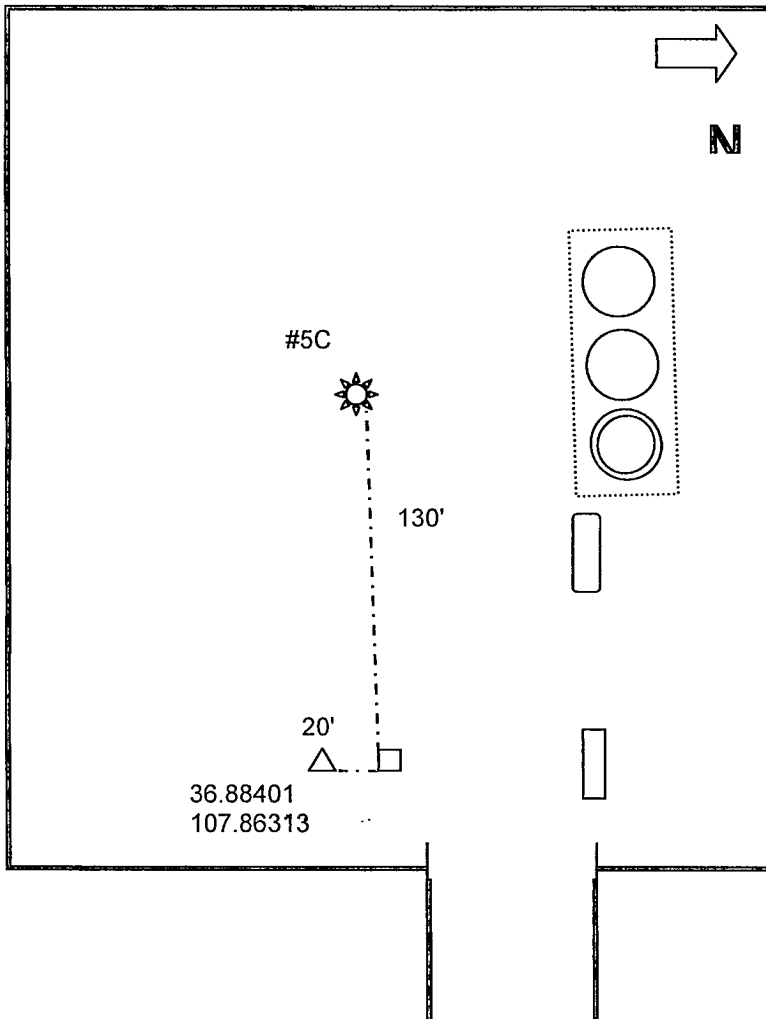

Drill ground bed approximately 130' east of #5C wellhead at staked location. Install single-well solar unit and install cables to new ground bed and #5C wellhead at lengths below.
