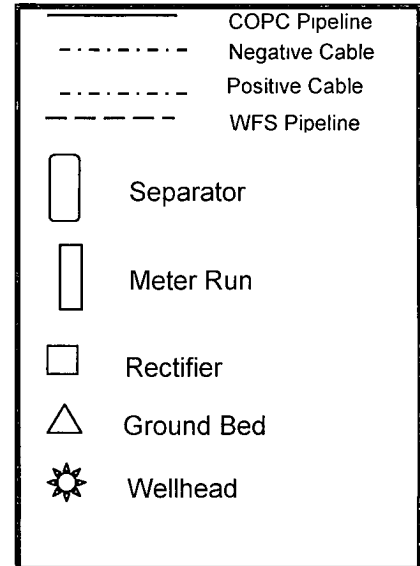
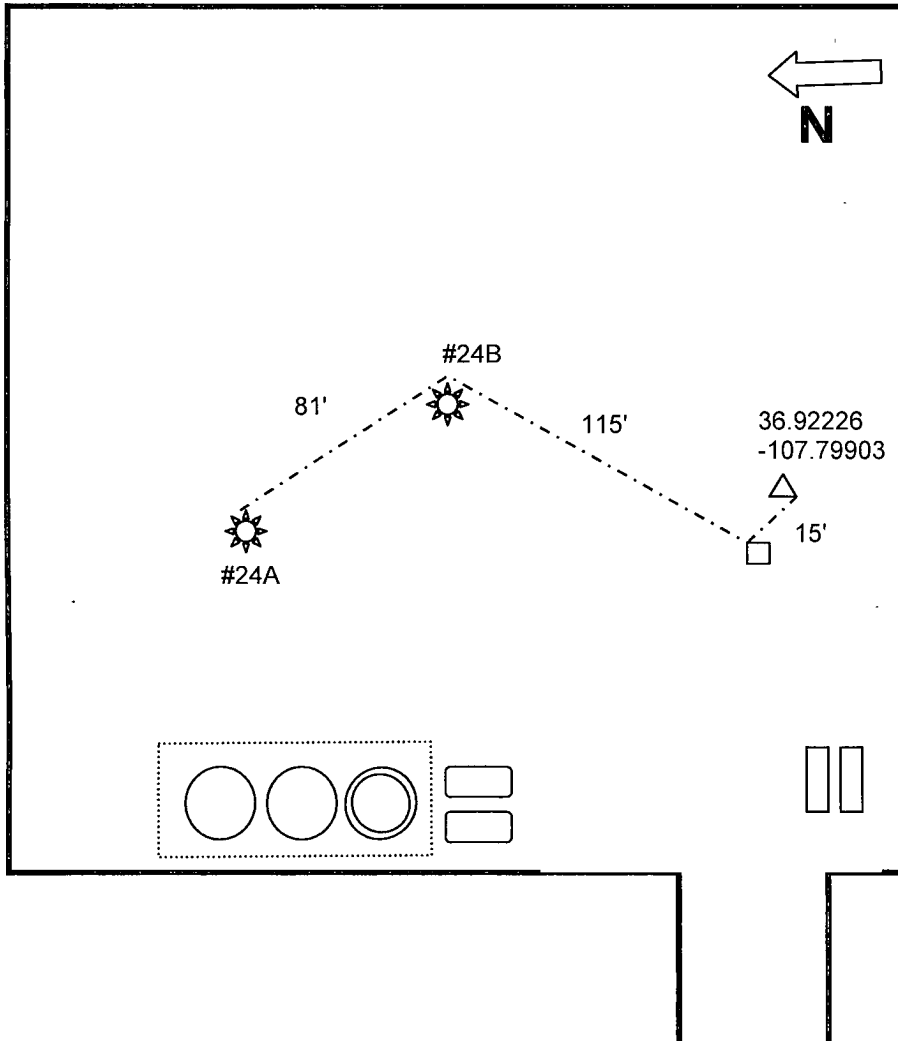

# San Juan 32-9 #24B

Section 05, T31N, R09W, San Juan County, NM



Drill ground bed approximately 115' southwest of #34B wellhead at staked location. Install 40-16 twin-well rectifier at staked location and tie-in to existing UGAC. Connect to groundbed, #24A and #34B wellheads at lengths below.
