4/25/12 Running Horse plugged the Sullivan #9 as follows:

Set a CICR at 950'. Pressure tested the tubing to 1000# - held OK. Loaded the annulus and pressure tested the casing to 750# - held OK. Established an injection rate into the perfs at 3.5 BPM at 50#. Pumped 36 sx (42.5 cu.ft.) of CI "B" neat cement below the CICR and left an additional 8 sx (9.4 cu.ft.) on top of the CICR. Perforated two holes at 328'. Established circulation via the bradenhead. Pumped 75 sx (88.5 cu ft.) of CI "B" neat cement down the 4-1/2" casing and out the bradenhead. Circulated 1 bbl of good cement to surface. Left the casing full of cement. SI the well. Installed the P&A marker. Plan to clean the location ASAP.
