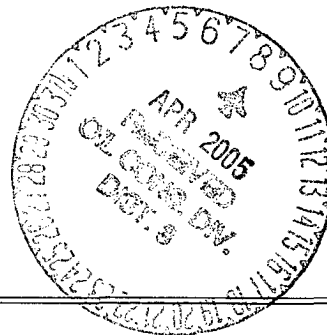

On 11/4/2004, 9 jts of 5 1/2", J-55, 15.5#, LT&C Liner was run to 3,258' with 0 sx of cement. Top of liner hanger is at 2,957'. Perforations are from 3,021' - 3,214', 4 SPF, 0.49", 280 holes. On 11/5/2004 ran back in hole with 107 jts of 2 3/8" tubing J-55, 4.7#, LT&C, end of tubing set at 3,235', return well to sales on 11/5/2004.
