Perforations are from 2,930' - 3,183', 4 SPF, 0.49", 280 holes, 90 degree phasing. On 10/7/2004 ran back in with 98 jts of 2 3/8" tubing J-55, 4.7#, LT&C, end of tubing set at 3,231', return to sales on 10/8/2004.
