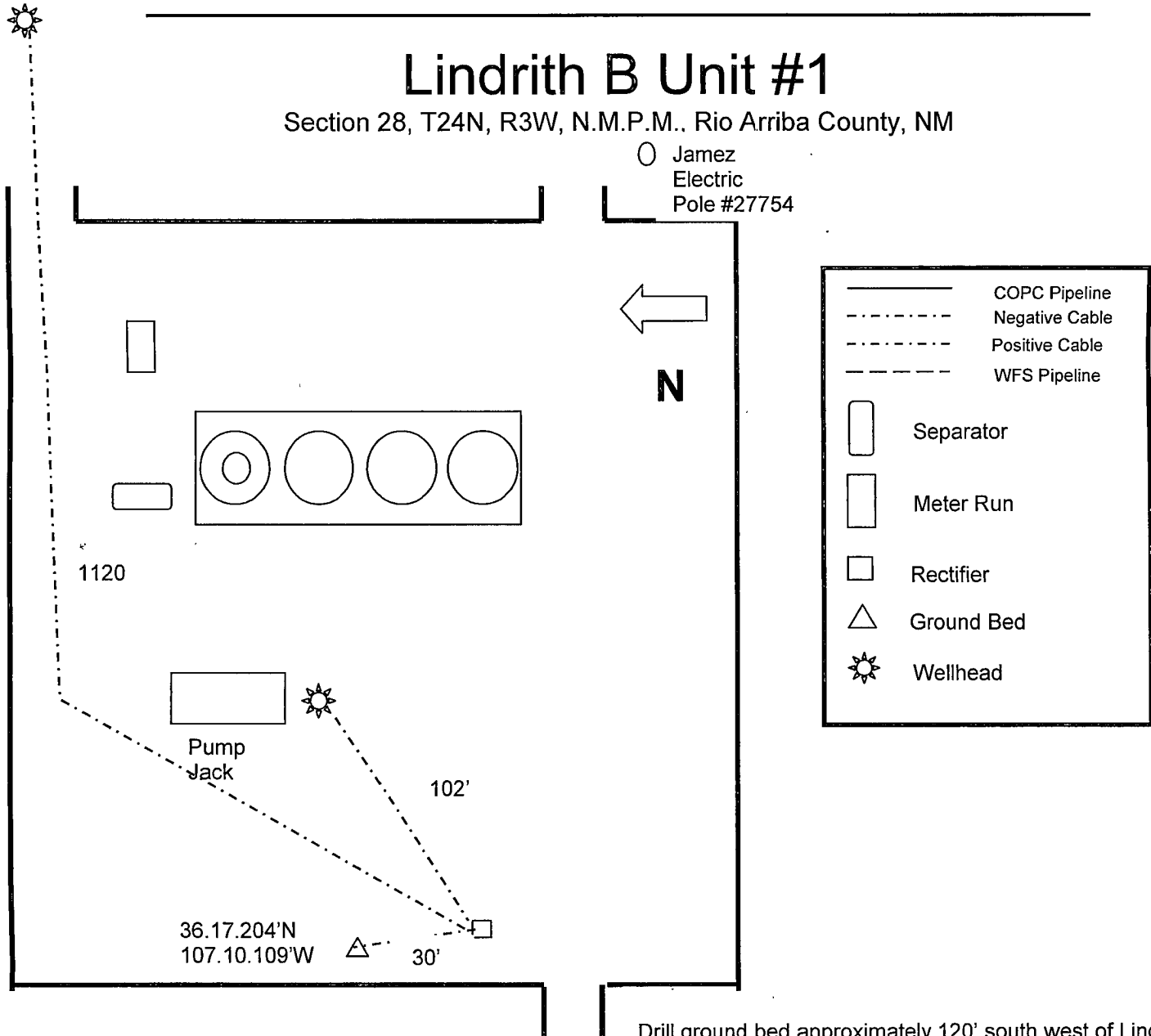

Install 40-16 rectifier at staked location and plow in UGAC to Jamez Electric pole #27754 where we will need a meter pole set near road. Install cable to new ground bed and to Lindrith B Unit #1 and Lindrith B Unit #45 well head's at lengths below.
