We wish to temporarily abandon the well based on the pressure test attached to this sundry. We completed this well in May of 2001 in the Fruitland coal and have not been able to establish production. In order to test the integrity of the casing, we moved a compressor on the well and pressured up to 533 psig. Reading the chart, after the well was pressured to 533 psig, we recorded an average 8 psig drop after 1 1/2 hours.
