

Cement first stage with +/- 300 sx Prem Lite HS cmt w/additives mixed @ 12.5 ppg & 2.01 cuft/sx followed by 150 sx Class "H" cmt w/additives mixed @ 14.2 ppg & 1.54 cuft/sx. Est TOC should be at or above the DV tool.

Cement second stage with +/- 500 sx Type III cmt w/gel & additives mixed @ 11.4 ppg & 3.03 cuft/sx followed by 100 sx Type III cmt neat mixed @ 14.5 ppg & 1.41 cuft/sx. Circ cmt to surf.
