This well is part of an extensive gas sales line project that will be completed by 12/31/2005. The sales line will allow connection of numerous wells in addition to this one. The line is surveyed and the application is in progress. It is currently undergoing environmental assessments. The system will include gas and water lines to a planned disposal well. By gathering all wells in the area this will allow us to produce gas into the PNM lines at a large enough rate to run the compressor. We realize that this group of wells has languished for a period of time. We have spent a large amount of time planning and surveying the system. Its sheer size has caused delays beyond our original estimate. We will be able to complete the project before year end. We request we be given this time to complete this project.
