

Verbal approval received to D/O CIBP set @ 3124' to produce well and leave BH open during operations until 30 days prior to quarterly test. Quarterly tests will be conducted for a year and the well will be re-evaluated. The BH will be shut-in on 7/1/2012 and the test conducted on 8/1/2012 for the first quarter.
