Pre-flush w/ 50 bbls FW, 10 bbls GW, & 5 bbls FW spacer. Pumped 249 sx (319cf-57bbls=1.28 yld) Type III cement w/ 0.3% CACL2 & .25 pps cello-flake. Drop plug & displaced with 22 bbl FW. Bump plug w/ 1200#. Circ. 20 bbls cement to surface, WOC. ND BOPE. RD RR @ 16.00 hrs on 5/21/12.
