Energen Resources completed a Pictured Cliffs pay add to the Jicarilla 107 #3 in May, 2012. Despite all efforts, this zone has failed to produce. Therefore, Energen Resources plans to abandon the PC and resume MV production. Using the CBP already in the hole isolating the MV at 5290', enough cement will be pumped into the PC formation to seal off the formation. Then, the cement will be drilled out and the casing pressure tested to 600psi for 30 minutes. Then the CBP will be drilled out and the MV returned to production.
