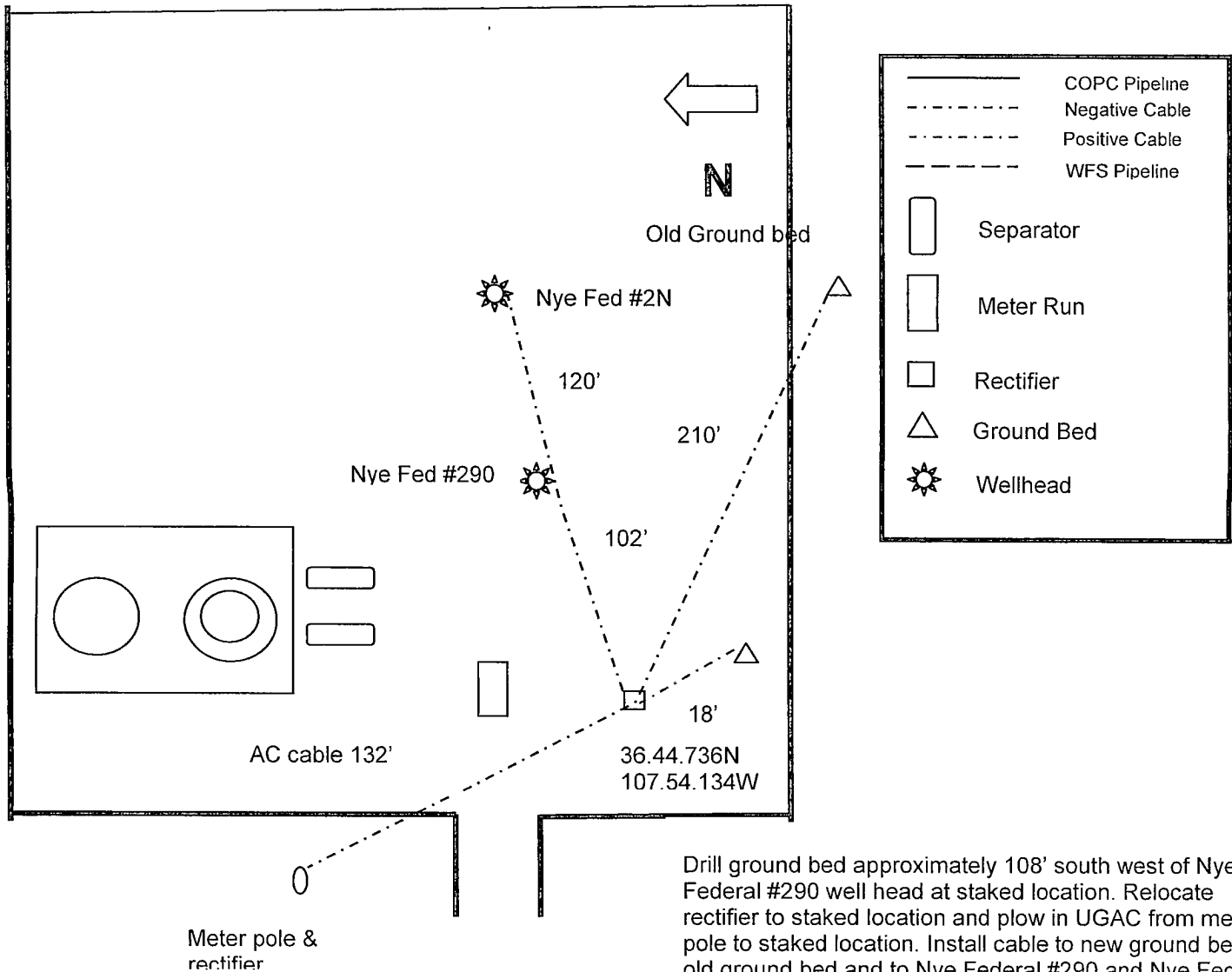

## Nye Federal #2N

Section 8, T29N, R10W, N.M.P.M., San Juan County, NM



Drill ground bed approximately 108' south west of Nye Federal #290 well head at staked location. Relocate rectifier to staked location and plow in UGAC from meter pole to staked location. Install cable to new ground bed and old ground bed and to Nye Federal #290 and Nye Federal #2N wellheads at lengths below. 20' of casing should be enough. There could be some river rock.
