Set 18 external swellable casing packers for isolation of production string at the following depths: (1) 9517', (2) 9283' (3) 9051', (4) 8820', (5) 8587', (6) 8353', (7) 8119', (8) 7885, (9) 7653', (10) 7421', (11) 7187', (12) 6952', (13) 6718', (14) 6485', (15) 6252', (16) 6020', (17) 5830', (18) 4921'.
