Hole diameter: 12.25" casing diameter: 9.625". Casing weight and grade 36# K55 LTC. Depth of 12.25" hole from 0 to 510' TVD/MD. Casing set from surface to 502' TVD/MD.

On 8/4/12 pumped 178 sacks Type III cement + 1% CaCl<sub>2</sub> + 0.25# Cello Flake + 0.2% FL-52A. Mixed at 14.6 ppg. Yield 1.38 cuft/sk. 6 bbls circ to surface. WOC 9 hours for surface casing.

Float collar at 458'. TOC at surface and BOC at 502'.

Casing and BOPs tested 8/5/12. Pressure held at 1500psi for 30 minutes. No pressure drop.

Started drilling out cement at 455' TVD/MD on 8/5/12.
