Set intermediate casing string and cemented 8/16/12. Gelled freshwater mud system.

Hole diameter: 8.5", casing diameter: 7", casing weight and grade 26ppf J55 LTC. Depth of 8.5" hole from 0 to 4716' MD. Intermediate casing set from surface to 4627' MD. Stage tool at 1690'. Top of float collar at 4617' MD. TOC at surface and BOC at 4627' MD.

Stage 1 Cement (Pumped 8/16/12): Lead: 196 sks Premium Lite FM + 3% CaCl₂ + 0.25#/sk Celloflake + 5#/sk LCM-1 + 8% Gel + 0.4% Sodium Metasilicate + 0.4% FL-52A. Tail: 156 sks Type III cement + 1% CaCl₂ + 0.25#/sk Celloflake + 0.2% FL-52A. Circulated 32bbbls to surface. WOC 4 hours.

Stage 2 Cement (Pumped 8/16/12): 154 sks Premium Lite FM + 3% CaCl₂ + 0.25#/sk Celloflake + 5#/sk LCM-1 + 8% Gel + 0.4% Sodium Metasilicate + 0.4% FL-52A. Circulated 20bbbls to surface. WOC 8.5 hours.

Started drilling out stage tool at 1687' on 8/17/12. Tested casing and BOP 8/17/12, pressure held at 1000psi for 30 minutes. No pressure drop.
