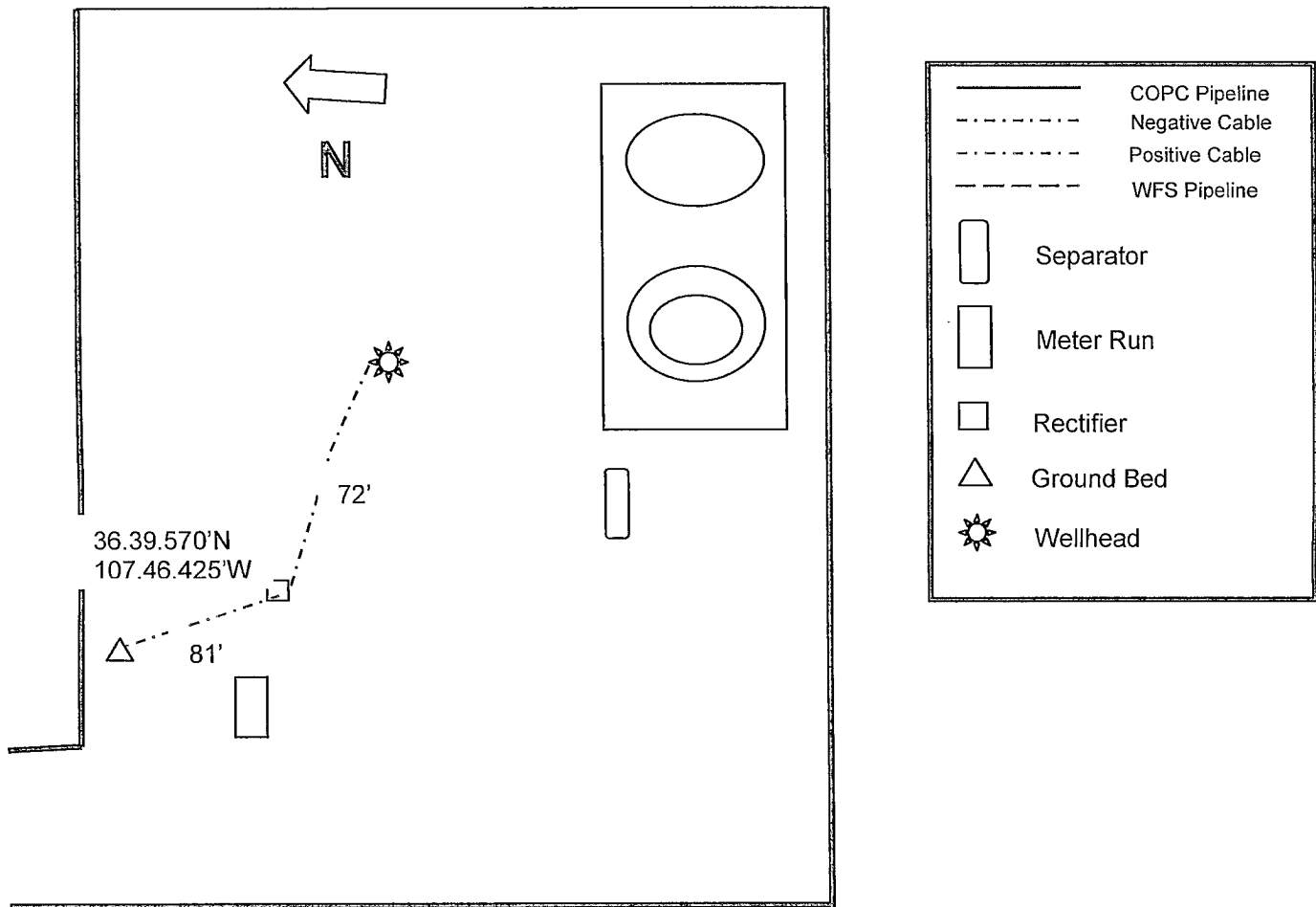

Section 15, T28N, R9W, N.M.P.M., San Juan County, NM



Drill ground bed approximately 123' North West of C #4N well head at staked location. Install single well solar at staked location. Install cable to new ground bed and to C #4N wellhead at lengths below. We could need 60' of casing. There should be no problem with rocks.
