Set 17 external swellable casing packers for isolation of production string at the following depths: (1) 9791', (2) 9529', (3) 9268', (4) 9006', (5) 8786', (6) 8524', (7) 8265', (8) 8045', (9) 7794', (10) 7522', (11) 7261', (12) 7041', (13) 6781', (14) 6520', (15) 6259', (16) 6038', (17) 5777'.
