Sept 2012: Pull 6029' of 2-3/8" tubing from this well. Set CIBP at 5910' above existing perforations. Ran CBL and found TOC at 4540'; DV tool at 3050' and cement to 8-5/8" shoe at 1421'. TIH with tubing. Righ up BJ. Plug #1 from 5910' to 5234' with 121 sxs cement. WOC overnight and tag cement at 5004'. PT casing to 500 PSI, held OK. Plug #2 from 5004' to 4544' with 40 sxs cement to cover Hermosa top. WOC overnight and tag at 4530'; RD and MOL.

Plugging: Plug #3 (Organ Rock) from 3750' to 3650' inside and outside with 51 sxs; perf and CR; Plug #4 (DeChelly) from 3130' to 3030' size same as plug #3; Plug #5 (Chinle) from 2286' to 2186' with 12 sxs inside casing; Plug #6 (8-5/8" casing shoe) from 1471' to 1371' with 12 sxs inside; Plug #7 (surface plug) 150' to surface. Set p&a marker.
